**ORDER**

**IT IS HEREBY ORDERED AS FOLLOWS:** The motion is granted.

1. Pursuant to 735 ILCS 5/2-1009 the claims of Plaintiffs, CHARIS BARKER, RUTH BURGER, JAMIE DEERING, RACHEL FROST, JANE DOE, JANE DOE III, JANE DOE IV, JANE DOE VI, RACHEL LEES, MEGHAN LIND and JENNIFER SPURLOCK, against Defendants, Institute in Basic Life Principles and William W. Gothard, Jr., are voluntarily dismissed without prejudice; and Plaintiffs' right to re-file and maintain a second action against said Defendants within one year pursuant to 735 ILCS 2-1009 and 735 ILCS 5/13-217 is expressly reserved.
